5. Constitutional Amendment

ARTICLE II: MEMBERSHIP OF THE MIDDLE COMMON ROOM

- c) Associate members shall be:
 - i. former ordinary members who are approved by the MCR Committee ii. any person engaged in study or research in Oxford, typically but not exclusively at an institution associated with the University of Oxford, not reading for an Oxford degree, who is considered to have the equivalent of the status of a Senior Student as defined in the Examination Regulations, upon application in writing to the Committee. The Committee's decision on membership, made following discussion with the Tutor for Graduates, shall be reported to the next Open

Meeting. By majority voting, an Open Meeting shall have the right to reject a proposal for Associate Membership. Associate Membership shall commence after the Open Meeting at which the proposal has been presented and not rejected.

The duration of the membership of an Associate Member shall be defined by the Committee and included in the proposal made to an Open Meeting. No Associate Membership shall be longer than three years. 19 in favor, 0 against, 3 abstentions. Motion passes.

6. Motions:

- a. The Committee motions to invest a portion of the profits from the Dia de los Muertos Entz either in a new television or in a data projector to allow for the continued entertainment of the MCR's members; we're looking to spend between £500-£700; after much discussion, *The MCR votes unanimously to table the motion until the next open meeting to take place on Sunday of WK8*. An email to the MCR announcing the date and agenda of the next open meeting on by mid-week WK4.
- b. The Treasurer moves, seconded by Co-President Lauren McGuirl to donate this term's £50 charity allowance to the Lincoln College Vacation Project. *Motion passes with 11 in favor, 2 against, and 6 abstentions.*
- 7. Special Election for the Open Position of Treasurer: Avi nominates Ubaid, Lauren seconds, Rachele thirds. *MCR unanimously votes Ubaid confident.* The new committee will be announced on Monday, February 7, 2005.
